This Addendum No.1 to the drawings and specifications shall supplement, amend and become a part of the quote documents, plans, and specifications for the Moores Pike (College Mall to Woodruff) Sidewalk. All bids and construction contracts shall be based on these modifications to the original contract documents. Bidders shall acknowledge receipt of this Addendum on the Bid Form. Failure to do so may subject the Bidder to disqualification.

Item No. 1: Questions and Answers

- (Q) The 2018 INDOT Specs call for the thermoplastic lines to be grooved into the surface and level with the asphalt. However grooving is normally a separate pay item. It would seem unnecessary in this instance on older pavement. I assume the intent is to just place them on the surface without grooving as done in the past?
 - (A) Grooving the pavement prior to thermoplastic will not be required with this contract. However, the contractor shall submit a copy of the Manufacturer's installation guide and will be responsible for following the Manufacturer's recommendations.
- (Q) Will there be a 12" pipe item created for the new pipe shown in the table on sheet 19?
 - (A) See the Corrected Schedule of Items included as part of this addendum. Two new line items have been added to the Schedule of Items.
- (Q) Also as a note I believe there is a sizable quantity mistake on CYD of topsoil. It shows the same CYD amount of topsoil as SYS seeding.
 - (A) See the Corrected Schedule of Items included as part of this addendum. Line item #19 Top Soil quantity has changed.

- (Q) Are there any available borings or as-built information on what the existing pavement depth is and whether there is concrete underneath?
 - (A) There are no available roadway as-builts plans and the design effort did not obtain borings on this project.
