If you are in a situation that requires immediate assistance from the police, fire department, or ambulance, please call 911.

Non-emergency contact for BPD

for situations that don't require an immediate response but still involve public safety or law enforcement

- Downtown Resource Officer (DRO) Number: 812-349-3952; DRO email: police-dro@bloomington.in.gov
- Email method - recommended for non-emergency and to build a record of incidences

Needle Pick-up & Disposal:

- If you have found an improperly disposed-of syringe in a public space in Monroe County, you may call (812) 349-2543, leave a message with your name, phone number, and the specific location of the syringe, and staff will respond during regular business hours.

uReport

IMPORTANT RESOURCES:

- ▶ The Housing and Neighborhood Development Department provides free “Pick It Up” program trash bags to clean up your neighborhood. Find out more at bton.in/P-i-U.



- ▶ Hazardous items that may not be included with regular trash include: syringes, prescription or over-the-counter drugs, any unknown liquid in a container, batteries. Check whether specific items are hazardous at bton.in/7nBKp. Hazmat may be disposed of at the Waste Reduction District of Monroe County (see below).

SYRINGE CLEAN-UP RESOURCES:
